Content:

1. Introduction to legal issues - the basic legal concepts and principles, the rule of law in Czech Republic, the legal sector, legal profession
2. Civil law - legal acts and their annulment, legal and natural persons, legal personality and legal capacity, rights and substantive evidence, contract
3. Business Law- companies and cooperatives, types of business, the Trade Code, types of trades
4. Labor Law- establishment and termination of employment, employment contract, agreement for work outside employment
5. Labor law - the rights and obligations of employers and employees, liable for damages
6. Sports Legislation- concept of sport, sport rules, basic human rights in sport, sports associations and clubs, civic associations, the relationship athlete vs Club
7. Civil liability and criminal liability in sport- general liability, liability for injuries to amateur and professional competitions
8. Security and legislation in education- provide swimming, skiing and other courses, prevention and management of injuries in TV, the responsibility for those entrusted
9. The fight against doping- concept, methods, penalties, Czech Republic Anti-Doping Committee, legal documents
10. Funding sport- sponsorship, grants, etc., illegal machinations of the sport
